## A BRIEF HISTORY OF THE CONFERENCE

The **Federal Mediation and Conciliation Service (FMCS)** began sponsoring federal sector conferences for labor and management leaders within Texas as early as the mid to late 1980s. The objective was to encourage more collaborative and cooperative relationships between the two as they confronted issues of mutual concern. In the 1990s, the FMCS also began sponsoring similar L-M conferences at the statewide and regional levels throughout the U.S.

At approximately the same time as FMCS was sponsoring forums for representative leaders from labor and management, the **University of North Texas (UNT)** was also experiencing success in sponsoring similar conferences in conjunction with their academic industrial relations program. FMCS and UNT representatives participated as speakers and workshop presenters in each of their respectively sponsored conferences.

In 1998, FMCS and UNT joined forces to co-sponsor the first private sector conference for organizational leaders from L-M relations and collective bargaining communities across Texas. This 1998 conference was held in Dallas and was attended by more than 100 labor and management participants, as well as several dispute resolution neutrals. Then in 1999, at our second annual L-M conference, almost 200 participants registered and attended. Following the success of the 1999 event, Conference planning committee members agreed to relocate the conference to San Antonio in hopes of attracting even greater participation. In year 2000, with participants from the federal and public sectors as well, Conference attendance reached more than 200 labormanagement leaders along with multiple dispute resolution neutrals from across Texas for this 3-day event.

In 2001, participation again modestly grew, thanks in large part to financial aid from private sponsors. In 2002, the *Alamo Federal Executive Board* joined the Board of Directors, serving as Executive Administrator and Treasurer. Conference planning increased from approximately 10 people in 1998 to over 30 active members of a chartered Board of Directors by 2018. Board membership includes private sector, public sector, and federal sector leaders from labor and management, as well as neutrals and academics from mediation and arbitration.

Beginning in 2003, upon joint recommendations from FMCS and UNT, the Board of Directors decided to enact a charter and by-laws. The Charter directs each succeeding annual conference to be chaired and co-chaired respectively by representatives from labor and management, with positions rotating each year. Over succeeding years, the TXLM Conference became a premiere networking and education event for leaders from labor and management, even attracting attendees from other states as well. Today, the TXLM Conference serves as a showcase forum within FMCS attracting nationally recognized speakers and presenters from the ranks of government, the U.S. military, international business interests, international union movement, think tanks, higher education, and innovative trend-setters within the greater L-M community.

## **CONFERENCE CHAIR**

#### **VIRGINIA PEREZ**



Virginia Perez is the Training Manager for the West Gulf Maritime Association, a Texas nonprofit corporation, which was organized in early 1968 to succeed the former local maritime associations in Houston, Galveston and Brownsville, Texas and to embrace within the membership of one Association the steamship owners, operators, agents along with stevedoring and/or terminal companies located in all Texas ports and the Port of Lake Charles, Louisiana. Jean Hervey was elected as International Vice President of her union in 1995 and served in that position until Saturday, March 27, 2021. She lives in Plumerville, Arkansas.

March 27, 2021, at Workers United International Convention she was elected International Executive Vice President of her union. Her term as EVP is four (4) years. The first African American and first women elected to this position within her union.

She is also the Regional Director for the Southwest Regional Joint Board based in Dallas, TX.

Mrs. Hervey's lifelong commitment to labor, economic and social justice began with her work as an organizer in Arkansas where she helped to organized workers in the clothing industry and Distribution Centers in southern Arkansas, Missouri, Kansas, Oklahoma, and Louisiana. She became the Manager of the Arkansas District of Amalgamated Clothing Workers of America, serving for 5 years and later became the Assistant Manager of the St. Louis District of Amalgamated Clothing &Textile Workers Union. In St. Louis Mrs. Hervey was responsible for merging 10 local unions to bring about a more effective way to actively serve the membership by combining collective bargaining and financial resources for better representation. Later, elected as Associate Director of Southwest Regional Joint Board and now serving as the Director.

In 1992, she was elected as the first African- American to serve the State of Arkansas on the National Democratic Committee as National Committee Woman where she served as the chair of the national Resolution Committee. She was elected as delegate to the Democratic Party Convention 1984, 1988, 1992, 1996, 2000.

In 1995, she was elected as Vice President of Workers United and serve on the International Union General Executive Board. Mrs. Hervey is a Trustee of the Union's National Health and Pension Fund and Sidney Hillman Foundation. She also served as a Director of Amalgamated Bank in New York for 5 yrs.

Mrs. Hervey's commitment to her community, state and nation is shown by Governor's Bill Clinton, Jim Guy Tucker and Mike Beebe appointed her to boards, commissions, which included Economic Development, Labors Representative on Unemployment and one (1) of the five (5) Commissioners on the Alcohol Beverage and Control Board (ABC) with a 6-year term.

Mrs. Hervey became the first Woman and first African American to serve as chair of Conway County Democratic Committee. She was a Conway County Election Commissioner for 18 years, helping to oversee the electoral process for Conway County.

She is affiliated with many organizations and carry a leadership role in most, such as Coalition of Black Trade Unionist (CBTU), Coalition of Labor Union Women, NAACP, A Phillip Randolph Institute (APRI) National Pay Equity Foundation, National Black Women's Conference, and St. Jude Children Research Hospital. She serves as an Advocate for Cervical Cancer & HPV Prevention.

She is a member of the Mt. Carmel Missionary Baptist Church in Plumerville where she is a Deaconess and the Chair of the Beautification Ministry. She was induction in 2019 into the organization of Top Ladies of Distinction as Lady Jean. TLOD is a national organization which focus on Youth Organization (Top Teens of America), improving the Status of Women, Service to Senior Citizens, Community Beautification, and Community Partnerships.

#### **RICK LEVY**





As the Association's national president, Dave was called upon multiple times to testify before Congress on labor-related legislation and regulation. He met frequently with U.S. Department of Labor Secretaries, as well as White House staff on issues affecting working families.

During his full-time position as a Federal Mediator (1996-2018), Commissioner Renfro served as adjunct faculty for the University of North Texas where he created and taught graduate and undergraduate courses in conflict resolution. His courses included: Workplace Dispute Resolution; Hostage Negotiations and Crisis Intervention; Dynamics of School Conflict; Dispute Resolution and Globalization; as well as Foundations of Conflict Resolution. Renfro also presented the hostage and crisis course in workshop format to several federal and state law enforcement organizations, as well as the Texas Association of Hostage Negotiators. Additionally, he volunteered as an intervener at the Dallas County Suicide and Crisis Center. 



## **2023 HALL OF FAME INDUCTEES**

#### SHAREEN LARMOND



Shareen Larmond is President of the West Gulf Maritime Association, a maritime trade association representing the interests of almost 200 companies in the maritime community. Its membership includes ocean carriers, operators, ports, agents, terminal companies and stevedores located in Texas. The Association primarily negotiates and administers the multi-employer collective bargaining agreements with the International Longshoremen's Association in all ports in both Texas and Louisiana. Her official appointment on January 31, 2018, as President made Ms. Larmond the first female and first person of color to run the West Gulf Maritime Association in all its 50-year history. It also made her the first female to head a Port Association of its kind in the country.

In 2018, Ms. Larmond increased company profits and successfully guided employers through labor negotiations ultimately producing and implementing fourteen collective bargaining agreements ensuring a peaceful labor climate in Texas over the next several years.

In addition to her executive duties at the Association, Ms. Larmond serves as a trustee on several Taft-Hartley and managed health benefit plans with assets totaling almost \$2 billion.

Prior to her appointment as President, Ms. Larmond was employed as the Association's General Counsel and oversaw all aspects of litigation most notably discrimination and harassment cases as well as enforcement of the multi-employer collective bargaining agreements.

Prior to her maritime work, Shareen Larmond served as General Counsel for State Senator John Whitmire, Dean of the Texas Senate. For over five years, she performed advanced and complex legal and legislative analytical work in both Austin and Houston. Ms. Larmond was fortunate to have a part in many of the major criminal justice reforms that took place in 2007.

She is active in both maritime and local communities. She is a board member for the Lower Kirby Pearland Management District. She has been a board member for the District since its statutory creation in 2007 and currently serves as the District's President. Ms. Larmond is a Co-Administrator for the J.H. "Buddy" Raspberry Scholarship Trust Fund, which awards educational scholarships for individuals in the maritime industry. She also holds board positions on the Gulf Coast Workforce Development Board and the Economic Alliance Houston Port Region.
